Students apply the advanced knowledge, and skills of community health nursing to enable them to a acquire the ability of problem solving, research critique and critical thinking in providing comprehensive high quality nursing care either at home or community setting focusing on health promotion to the individual, family and community at large.

Attributes of the graduates (ARS) Post graduate of master program in family and community health nursing should be able to:

- 1. Apply the research process to improve clinical practice and contribute to knowledge development for family and community health.
- 2. Apply advanced nursing practice through utilization, participation, and identification of significant research problems in family and community health nursing.
- 3. Evaluate care delivery approaches that meet clients care based on scientific finding in family and community health nursing and other sciences.
- 4. Provide care that reflects sensitivity to differences among culturally diverse populations.







- 5. Identify human, material of the organizational system needs, facilities and barriers of the organizational system.
- 6. Integrate teaching principles, teaching / learning strategies, educational technologies to educate individuals, families, community and other health care professionals.
- 7. Communicate clearly and work effectively in a team.
- 8. Demonstrate leadership abilities related to family and community health nursing.
- 9. Demonstrate critical thinking, problem solving, and decision-making abilities to improve family and community health.
- 10. Use ethical principles to guide decision-making in nursing practice.
- 11. Utilize knowledge and skills in professional practice among diverse and multicultural populations.
- 12. Stimulate change within the profession and improve management of the health care delivery system by addressing legal and economic policies; psychosocial, cultural, and environmental factors that affect family and community health care.
- 13. Collaborate with health team members to improve healthcare in research field.
- 14. Integrate theoretical and research based knowledge in an advanced family and community health nursing practice.
- 15. Be a lifelong learner for continuous improvement of professional knowledge and skills.

- b.3- Integrate specialty related information and utilize research findings in community clinical practice.







- b.4- Utilize research finding, evidence based practice strategies, technology and creativity to improve the delivery and outcomes of health care at occupational setting.
- b.5- Evaluate specialty related dangers at the different setting of the community.
- b.6- Plan to establish and monitor standards of practice to improve patient care in collaborations with other nursing expertise at the different settings of the community.
- b.7- Apply ethical principles to guide decision making in nursing practice at school setting.
- b.8- Integrate the concepts of caring in nursing practice in community health nursing
- b.9- Promote critical thinking which leads to the formulation of research questions and hypotheses at occupational setting.
- b.10- Demonstrate advanced knowledge and synthesis of teaching and learning theories for individuals, groups and community.
